

**ATTENTION RESIDENTS**.....The Village of White City would like to provide a courtesy notice, at this time, to all village residents to make everyone aware of some of the Village's Ordinances that are not being followed. The ordinance violations listed below are all punishable by law and if not followed or corrected fines will be issued and corrective action pursued vigilantly.

1. It is unlawful to deposit any material on any street which may be harmful to the pavement thereof or any waste material, or any grass clippings, or to cause a lawn mower to blow grass clippings onto a street or any other articles such as glass. (See ordinance 65 ILCS 33-2-9)
2. It is unlawful to deposit on any sidewalk, any material such as waste material (including but not limited to grass), glass or any other articles. (See ordinance 65 ILCS 33-2-8)
3. No trash receptacles shall be left on or near roadside / sidewalk for more than 24 hrs. after trash pick-up.
4. It shall be unlawful for anyone to permit any weeds, grass, or plants, other than trees, bushes, flowers or other ornamental plants, to grow to a height exceeding eight (8) inches anywhere in the Village. (65 ILCS 25-2-2)
5. No open burning of any paper, garbage, refuse, waste or any vegetable or plant or refuse, including, but not limited to tree trimmings, weeds, leaves, grass, yard trimmings and crop residues or any combustible material is prohibited. Waste burning is allowed between the hours of 6:00 AM and 6:00 PM. (65 ILCS 27-9-1)
6. No burning barrels or burning receptacles shall be used by any person, unless said, burning barrel or burning receptacles are located in the rear yard. (65 ILCS 27-9-2 (B))
7. It is declared a nuisance and to be against the health, peace and comfort of the Village for any person within the limits of the Village to permit the following: Filth (65 ILCS 25-1-1 (A)), Noxious Odors (65 ILCS 25-1-1 (G)), Storing Debris (65 ILCS 25-1-1 (J)), Filthy Premise Conditions (65 ILCS 25-1-1 (N)), Litter on Streets (65 ILCS 25-1-1 (P)), Accumulation of Junk and Trash (65 ILCS 25-1-1 (Q)), Accumulation of Debris (65 ILCS 25-1-1 (Y))
8. Persons owning, occupying or in control of any public place or private premises shall keep the sidewalks and alleys adjacent thereto free of litter. (65 ILCS 27-5-5)
9. The Owner or person in control of any private premises shall , at all times, maintain the premises free of Litter (65 ILCS 27-5-6 (A))and shall collect, in such a manner , litter in such a way as to prevent it from being carried or deposited by the elements upon public place or private premises. (65 ILCS 27-5-6 (B))
10. All vacant structures and premises thereof or vacant land shall be maintained in a clean, safe, secure, and sanitary condition as provided herein so as not to cause a blighting problem or adversely affect the public health or safety. (65 ILCS 29-5-3)
11. All exterior property areas and premises shall be maintained in a clean, safe, and sanitary condition free from any accumulation of rubbish or garbage. (65 ILCS 29-5-4)
12. Except as otherwise provide in this Chapter no person shall keep with the Village any cattle, cows, horses, sheep, swine, goats, chickens, ducks, turkeys, geese, rabbits, or other livestock. (65 ILCS 3-1-10)

13. The owner of keeper of a dog shall keep the dog under restraint at all times and shall not permit such dog to be at large, off the premises of the property of the owner or keeper, unless the dog is under complete control . (65 ILCS 3-1-2)
14. All inoperable motor vehicles on public or private property and in view of the general public, as set forth herein, are a nuisance. (65 ILCS 25-4-2)
15. Reckless, negligent, or careless driving – It is unlawful to operate any vehicle in the Village in a careless, reckless, negligent, or wanton manner, or carelessly so as to endanger life or property. This includes off road vehicles (i.e. ATV's; 4-wheel vehicles) (65-24-4-8)
16. No camping trailer or other vehicle shall be used as living quarters. (65 ILCS 40-4-2(A)); No camping trailer or other similar recreational vehicle shall be used as an office or for any other commercial purpose unless a special use permit is granted from the Village. (65 ILCS 40-4-2(B)); No camping trailer, boat, boat trailer, RV or other similar recreational vehicle shall be parked on any front yard or on the side yard abutting a street. (65 ILCS 40-4-2(C)).
17. On corner lots, in the triangular portion of land bounded by the street lines that are thirty (30) feet from the point of intersection, no obstruction, whether natural or man-made, shall intrude into the air space that is between three (3) and ten (10) feet above the level of the adjacent street. (65 ILCS 40-3-14(B)).
18. No parking of any vehicles on a city sidewalk. (65 ILCS 24-6-4(A)(1)(b)).
