

ORDINANCE 383

CONTRACT RATES FOR CURB SIDE RESIDENTIAL REFUSE COLLECTION AND DISPOSAL SERVICES FOR THE VILLAGE OF WHITE CITY MACOUPIN COUNTY ILLINOIS

WHEREAS, the Village of White City has advertised for bids for weekly trash pickup; and

WHEREAS, bids have been received for trash pickup; and

WHEREAS, the Village wishes to cause the cost for said trash pickup to be made part of the water bills of the residents of the Village of White City; and

WHEREAS, trash pickup shall be made for each individual, in city limits, who pays water bills to the Village of White City;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF WHITE CITY, MACOUPIN COUNTY, ILLINOIS, as follows:

SECTION I: That there shall be assessed against each water user in the village limits of the Village of White City the sum of \$14.00 per month for weekly trash pickup beginning July 2018 through June 2019.

SECTION II: That there shall be a built in 4% annual price adjustment for the next two years. (\$14.56 for Year 2-2019-2020; \$15.14 for Year 3-2020-2021)

SECTION III: That if customer requests a second Toter Cart for their residence inside the village limits of the Village of White City the additional sum of \$7.00 will be included per month for weekly trash pickup beginning July 2018 through June 2019. There shall be a built in 4% annual price adjustment for each additional Toter Cart for the next two years. (\$7.28 for Year 2-2019-2020; \$7.57 for Year 3-2020-2021).

SECTION IV: That the cost for weekly trash pickup shall be a part of the water bill sent to customers each month.

SECTION V: That if any residents' water is shut off for non-payment the village will continue trash pick-up for the resident until bill is paid in full and the reconnect fee is paid in addition the Village will require an additional \$25.00 trash reinstatement fee prior to the water being turned back on to cover administrative costs.

SECTION VI: That all garbage must be curbside by 7:00 AM on date of pickup.

SECTION VII: That no garbage; yard waste, etc. will be picked up outside of the Trash Toter.

SECTION VIII: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

SECTION IX: That all Ordinances in conflict herewith are hereby repealed.
