#### **ORDINANCE NO. 430**

### AN ORDINANCE ADOPTING AND ESTABLISHING ANNUAL TAX LEVIES FOR THE VILLAGE OF WHITE CITY, MACOUPIN COUNTY, ILLINOIS FOR THE YEAR 2022.

WHEREAS, The Village of White City, Macoupin County, Illinois is authorized by the Illinois Municipal Code (65 ILCS 5) and other applicable statutes to adopt and levy Ad valorem taxes on taxable property within the corporate limits of the Village of White City to defray the expenses of providing public services and administering the Government of the Village of White City; and

WHEREAS, the President and Board of Trustees of the Village of White City have determined that there is a need to establish and adopt tax levies with the Village of White City to provide for the payment of such expenses; and

WHEREAS, the President and Board of Trustees of the Village of White City have heretofore adopted a budget making appropriations for the Village of White City.

NOW, THEREFORE,

BE IT ORDAINED by the President and Board of Trustees of the Village of White City, Macoupin County, Illinois as follows:

SECTION 1: That the amounts hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the Village of White City as that property is assessed and equalized for the current year, and for the following purposes: General Corporate, Police Protection, Fire Protection, Audit, and Liability Insurance for the Village of White City, Macoupin County, Illinois, 2021 Payable 2022 Tax Levy.

SECTION 2: That the amount levied for each object and purpose is placed in a separate column under the heading. "Amount to be raised by Tax Levy", which appears over same being as follows, to wit:

That the authority for the foregoing amount to be levied and the amount levied pursuant to each such authority is as follows:

GENERAL Corporate Tax (65 ILCS 5/8-3-1)	\$771.00
Insurance Tax (745 ILCS 10/9-107)	\$961.00
Audit Tax (65 ILCS 5/8-8-8)	\$574.00
Police Protection Tax (65 ILCS 5/11-1-3)	\$260.00
TOTAL	\$2,566.00

SECTION 3: That the Village Clerk shall make and file with the County Clerk of Macoupin County, Illinois a duly certified copy of this ordinance together with a Certificate of Needs.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance be in full force and affect after its adoption, as provided by law.
