ORDINANCE NO. 395

AN ORDINANCE AMENDING WATER RATES

BE IT ORDAINED BY THE PRESIDENT AND THE BOARD OF TRUSTEES OF THE VILLAGE OF WHITE CITY, MACOUPIN COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Section 38-4-11 of the Revised Code of Ordinances of the Village of White City, Macoupin County, Illinois, is hereby changed and amended to read as follows:

38-4-11 WATER RATES. There shall be established the following rates and charges for the users of the water system of the Village, based upon the amount of water consumed as follows:

- (A) <u>Water Users Residential Inside Village.</u>
- First 1,000 gallons MINIMUM PER MONTH CHARGE \$9.63
- Over 1,000 gallons \$9.63 per 1,000 gallons
- (B) Water Users Commercial Inside Village.
- First 1,000 gallons MINIMUM PER MONTH CHARGE \$12.02
- Over 1,000 gallons \$12.02 per 1,000 gallons
- (C) <u>Water Users Residential Outside Village.</u>
- First 1,000 gallons MINIMUM PER MONTH CHARGE \$12.38
- Over 1,000 gallons \$12.38 per 1,000 gallons
- (D) <u>Water Users Commercial Outside Village.</u>
- First 1,000 gallons MINIMUM PER MONTH CHARGE \$14.76
- Over 1,000 gallons \$14.76 per 1,000 gallons
- (E) <u>Debt Service Charge</u>: A monthly debt service charge of **Seven Dollars** (\$7.00) per month will be collected from all water users for Water System Debt which shall be applied to pay the bond debts associated with the water system.
- (F) Minimum Payable. Every residence, mobile home, immobilized mobile home, structure, multiple-family unit, business or industry connected to the water system shall pay the minimum per month. Even though there may be only one meter, each of the above users shall pay the minimum.

SECTION II: This Ordinance shall be in full force and effect from and after the date of its passage, approval and publication as required by law.
